Privacy Policy:

Amazing Excel ("**Amazing Excel**") operates Amazingexcel.com and may operate other websites. It is Amazing Excel policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Amazing Excel collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Amazing Excel purpose in collecting non-personally identifying information is to better understand how Amazing Excel visitors use its website. From time to time, Amazing Excel may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Amazing Excel also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on Amazingexcel.com blogs/sites. Amazing Excel only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Amazing Excel websites choose to interact with Amazing Excel in ways that require Amazing Excel to gather personally-identifying information. The amount and type of information that Amazing Excel gathers depends on the nature of the interaction. For example, we ask visitors who sign up at Amazingexcel.com to provide a username and email address. Those who engage in transactions with Amazing Excel are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Amazing Excel collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Amazing Excel. Amazing Excel does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Amazing Excel may collect statistics about the behavior of visitors to its websites. Amazing Excel may display this information publicly or provide it to others. However, Amazing Excel does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Amazing Excel discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to

process it on Amazing Excel behalf or to provide services available at Amazing Excel websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Amazing Excel websites, you consent to the transfer of such information to them. Amazing Excel will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Amazing Excel discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Amazing Excel believes in good faith that disclosure is reasonably necessary to protect the property or rights of Amazing Excel, third parties or the public at large. If you are a registered user of an Amazing Excel website and have supplied your email address, Amazing Excel may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Amazing Excel and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Amazing Excel takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Amazing Excel uses cookies to help Amazing Excel identify and track visitors, their usage of Amazing Excel website, and their website access preferences. Amazing Excel visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Amazing Excel websites, with the drawback that certain features of Amazing Excel websites may not function properly without the aid of cookies.

Business Transfers

If Amazing Excel, or substantially all of its assets, were acquired, or in the unlikely event that Amazing Excel goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Amazing Excel may continue to use your personal information as set forth in this policy.
